We are therefore proud that Latvia is one of the seven EU Member States which, at the initiative of the Ministry of Agriculture, has developed its own national Bioeconomy strategy. The Latvia Bioeconomy Strategic Research Alliance has been established in Latvia, which combines leading scientific institutes of the sector in order to increase the performance and competitiveness of bio-economy innovation at regional and international level, as well as Latvia's contribution to the overall EU goals.

We believe that key tools to help to take advantage of the bioeconomy potential are related to knowledge and innovation transfer, consulting services, cooperation of research and business, education and science, with particular emphasis on the significance of "Horizon Europe". It should be accentuated that, in our opinion, the involvement of agricultural experts in the "Horizon Europe" debate should become more important.

Considering that the scope of the 7th Cluster is currently extensively expanded, there is reason to fear that the funding planned for agriculture, food and natural resource innovation, as well as for research, may not make a significant contribution to the development of this area, since the section of environmental research is added to this cluster.

Assessing the role of science, innovation and their transfer in the future development of national economy, we see the need for more active involvement and representation of the Ministry of Agriculture in the international cooperation models.

I wish for fruitful discussions and strengthening of cooperation at the regional level of the Baltic States and the EU level, finding new and effective solutions for overcoming future challenges.
