



Geopraphical Features of Turkey









Overview to Agriculture Sector

Turkey is the first in Europe since 2005 in terms of Agricultural GDP.



Turkish agriculture sector meets the food requirement of **81** million Turkish citizens, **40** million tourists and **4** million refugees (3.5 million-Syrian) and exports agricultural and food products which accounts **16.9** \$ billion to nearly **200** countries.

• World Agriculture

- > GDP: **5.4 \$ billion** (2017)
- Trade Volume: **1,533 \$ billion** (2017)
- Population: 7,550 million (2017)
- One of the largest agricultural economies in the world,
 - > 1st in the Europe,
 - > 15th in arable land in the World (1st in Europe),
 - A top producer and exporter of crops ranging from hazelnuts and chestnuts to apricots, cherries, figs, olives, tobacco and tea.

Why we need a bioeconomy strategy

- Brings a new approach to economic processes
- Provides new production areas and employment opportunities
- Increasing environmental perception will bring a macro view to the public
- Dispersed works on bioeconomy reduce effectiveness (biotechnology, zero waste, farming 4.0, smart farming etc.)
- Compiles with similar works under the umbrella of bioeconomy will aim to diversify common objectives and ensure resource efficiency
- Serves the reuse of biobased waste to the economy

- Data accessibility
- Having a lot of thematic areas
- Persuading the bureaucracy (high level)

- Strategy preparation and monitoring








