

Aligning priorities and coprogramming of research (common **SRIA**)

- Contributions by countries (cash or in-kind)
- Additional funding by the Commission (usually funding rate of 30%)



Horizon Europe Strategic Programme Committee meeting on 19 Dec 2023 – SPC positions on the Commission services' assessments:

- 24 MS (AT, BE, CZ, DE, DK, EE, EL, ES, FI, FR, HR, IE, IT, LT, LU, LV, NL, NO, PL, PT, RO, SE, SI, SK) supported the 'European Partnership on Forests and Forestry for a Sustainable Future' as proposed (out of 27)
 - The European Co-Funded R&I Partnership on Forests and Forestry for a Sustainable Future is included as one of the nine new Partnerships in the Horizon Europe Strategic Plan 2025-2027 for research and innovation (adopted 20 Mar 2024)

- Implementation mode: Co-funded European Partnership
 - 6 (Food, Bioeconomy, Natural Resources, Agriculture and Environment)
 - 7-10 years (expected start Q1/2026)
 - 70 M€ (30%)
 - + MS contributions of min. 163 M€ (70%) = 233 M€
 - + leverage effect of other contributions
 - >> Sum total of all contributions 300-500 M€

Forests and Forestry for a Sustainable Future

Expected partners

The diversity of forestry challenges at local, regional, national, European and international level requires wide participation in the Partnership:

- MS/AC ministries, research funders and other public authorities of more than 20 countries
- FOREST EUROPE, BIOEAST, European Forest Institute (EFI)
- Platforms: European Forest-Based Sector Technology Platform (FTP), InnovaWood, European Hardwoods Innovation Alliance (EHIA), EEA, European National Forest Inventory Network (ENFIN), European Research Infrastructure Consortium (ERICs), NetworkNature
- Other collaborations, such as:
 - Industry (esp. SMEs), regions and other economic actors (incl. forest owner associations)
 - Biodiversity and conservation actors
 - Non-research organisations (e.g. NGOs) that produce knowledge on forests and society
- INCO feature The global perspective on forests



Compliance with the legal base

- Overall/effectiveness: rationale for a European Partnership approach
 - Improved cross-coordination of the European R&I landscape
 - Improved coordination across different areas and sectors
 - Stronger focus on the processes that lead to transformations toward sustainability in the forest-based and bioeconomy sector at EU level
 - Building of capacities, education and training, and a better connection of these with research
 - Mutualised benefits from the greater diversity of forest-related experiences and forest conditions at the European level



Directionality

- **Objectives**: A research and innovation-oriented transdisciplinary instrument that supports the EU Forest Strategy simultaneously with climate targets and the Biodiversity Strategy.
- Expected impacts:
 - Stronger consistency between social, environmental and economic dimensions of forests and forestry
 - > Better understanding of the role of forests in climate change and biodiversity targets
 - Improved guidelines on adaptive forestry regimes in European regions
 - New knowledge to support major transitions and innovations in the forest-based bioeconomy towards higher added value
 - Improved, consistent, comprehensive and timely monitoring of forests in line with the Commission proposal for a Regulation on a monitoring framework for resilient European forests

SCAR

European

- New green forestry business models
- NOTE: Support from Horizon Europe <u>EUFORE</u> project to develop the SRIA

Additionality: demonstration of EU added value

- Better coordination of forest research between countries
- Better integration of scientific programmes across countries to address common challenges and opportunities
- Learning from the strengths of the forest research in each country
- Possibility to pool MS resources to joint activities with national funding bodies and research organisations

Complementary Partnerships: \succ

• Agriculture of data; Biodiversa+; Accelerating farming systems transition - Agroecology living labs and research infrastructures; Circular Bio-Based Europe; Water4All; Built4People; Safe and sustainable food systems

Other initiatives: \succ

 Missions; forest dedicated platforms and initiatives under the European Green Deal; COST -European Cooperation in Science and Technology - EU-Farmbook, CAP Strategic Plans, LIFE etc.

Avoiding overlaps:


- Turning potential overlaps into synergies through holistic approach and integrated solutions across domains (e.g. terrestrial & water ecosystems, forests & soils)
