2012: Widening of SCAR




SCAR Components

- > European Commission (secretariat and chair, DG RTD & DG AGRI)




SCAR Main Activities

2. SCAR Steering Group



- Possible strategic research agendas in these specific areas.




5. Strategic Working Group (SWG)

Participants:

- SCAR members
- EC Staff

Main tasks:

- Discuss strategic matters on broad issues. Contribute to medium long-term research and innovation policy
- Formulating research policy advice on:
 - Fisheries and aquaculture research (SCAR FISH);
 - Agricultural knowledge and innovation systems (SCAR AKIS);
 - Sustainable bioresources production (Bioeconomy SWG);
 - Forestry research and innovation (SCAR Forest);
 - European Agricultural Research towards greater impact on global challenges (SCAR ARCH).
 - Food Systems (SCAR Food Systems)





Strategic Working Groups deliverables

Deliverables

Mapping and analyses of current research and innovation policies to identify common strategic goals and initiatives, normally covering larger domains than CWGs.

Concrete advice for countries and the COM on strategic research

Possible **strategic research agendas** (SRA) in the chosen domain (though thisis usually the role of the CWGs).

Advice on, and promotion of, the alignment of MS and European R&D policies, going beyond the EU Horizon 2020-related instruments (e.g. roadmap, strategy),

Advice on strategic convergence of areas currently distant from each other, Agricultural Research and Agricultural Research for Development, where there is the potential to increase synergies and/or reduce unnecessary duplication.





SCAR SWG FOOD SYSTEMS



- The main rational for the SCAR SWG Food Systems is to provide the strategic advice and support to the EU Research and Innovation policy framework FOOD2030.
- Currently the FS SWG are working on the mapping for the five past years R&I funding related to Food Systems at national and regional level and how it fits with key areas of FOOD 2030.





Qualitative and Quantitative Mapping



The mapping exercise includes QUALITATIVE and QUANTITATIVE Mapping:

- Qualitative mapping is on the integration of different policies related to Food and Nutrition Security and Bioeconomy policies in each Member State. It describes the specific situation in each country, the lack of consistency and the ambitions to achieve.
- Quantitative mapping aims to :
- ✓ evaluate how food and nutrition security and sustainability are included in each MS.
- ✓ to show the coherence between the policy and funding.
- ✓ to get an overview of status, to reveal knowledge and to arise opportunities to collaborate in order to fulfil the FOOD 2030 expectations.
- The mapping results will be presented in a booklet during the FOOD 2030 HLC in Plovdiv (BG) on the 14-15 June 2018.

- Preparation of reflection paper on the role of SCAR

Extend your network

Exchange of knowledge

- Acquire mutual knowledge of activities, institutions and facilities in Member States and Associated Countries.
- Help align national research programmes, avoid duplication of activities and ensure efficient use of resources.



Participate to the Strategic Programming

- Provide advice and support for the development of European initiatives such as the Joint Programming Initiative, the Commission Research Framework Programmes, development and the national programme coordination mechanism ERA-Net Co-fund.
- Bring in the debate your national/regional specificity and priorities.



Appointment process of SCAR delegates

- Delegates to the SCAR are nominated by the national Ministries (usually Agriculture or Research).
- Nominations must be submitted by the national Ministry to the Permanent Representation to the EU of the country.
- The Permanent Representation transmits the nominations to the European Commission DG RTD F "Bioeconomy" Directorate.
