SCAR conference "Humans in transitions: towards agroecological approaches and sustainable food systems"

The SCAR conference is held on 14 June 2022 in Paris, France. It is hosted by the EU French Presidency.

Paths for transitions are multiple and research has a major role to play in finding those. The way the SCAR working groups are addressing transitions is evolving from a silo-based to a more cross-cutting approach. Issues are tackled more holistically, allowing for closer cross-fertilisation among the various groups. The overarching goal of the conference is to engage and further motivate the SCAR working groups to tackle cross-cutting issues related to transitions.

The conference aims to foster discussion between SCAR members on the question "How to manage all the transitions (agroecosystems, food systems, knowledge systems) at the same time in order to have the human being as a focus point".

Highlights from the French Presidency

At the SCAR Steering Group Meeting on 11 March 2022, the French Presidency gave an overview of their priorities. The French Presidency called attention to the current difficult times due to the war in Ukraine and the effects of the COVID-19 pandemic. The Presidency highlighted that European food sovereignty, including protein autonomy, is now more important than ever. The need to push the agroecology transition forward, producing in a more sustainable manner, is more important than ever. Reducing pesticides and finding nature-based alternatives, applying low carbon agriculture, and keeping carbon in soils and agricultural markets alive are some of the levers promoted by the French Presidency. The French Presidency is supporting Cluster 6 Partnerships.

Candidate European Partnerships

European Partnerships under Horizon Europe are initiatives bringing together EU and a wide range of public and/or private partners. Partners jointly support the development and implementation of a common agenda for research and innovation activities. The partnership will coordinate, align, and leverage European and national R&I efforts.

European Partnership for sustainable food systems for people, planet and climate

The goal of the partnership is twofold. Firstly, the partnership is meant to ensure futureproof food systems through an integrated and transdisciplinary systems approach. It will also provide solutions to the Farm to Fork <u>Strategy</u>. The partnership will provide the scientific evidence, as well as the collaborative experience among professionals and citizens, to support the transformation of local, national, European, and global food systems. <u>Download the proposal</u>

European Partnership accelerating farming systems transition: agroecology living labs and research infrastructures

This partnership will tap into the potential of agroecology and local innovation. The goal is to accelerate the transition towards sustainable, climate- and ecosystem-friendly farming systems in Europe. The partnership will structure and support a network of agroecology living labs and research infrastructures. It will provide spaces for longterm, site-specific, multi-stakeholder and real-life experimentation, and will also deliver ready-to adopt practices that support farmers in understanding and implementing agroecological practices for positive economic, environmental, and social impacts. European Partnership for agriculture of data

This partnership will support sustainable agriculture in the EU, policy monitoring and policy implementation by using digital and data technologies in environmental observation.

The partnership will generate EU-wide data sets and information through combining geospatial and Earth Observation datasets. The goal is to provide solutions to the agricultural sector allowing for more efficient, environmentally friendly, and profitable production. Download the proposal

European Partnership for animal health and welfare

The European Partnership for Animal Health and Welfare aims to deliver key knowledge, services, tools and products to improve the monitoring and control of animal infectious diseases and animal welfare in a coordinated way. It will strengthen the preparedness of all actors and stakeholders, and support evidence-based intervention and policy making. This will sustain animal production and protect public health, and will reinforce the One Health-One Welfare principles through enhanced cross-sector collaboration. It will involve reference laboratories, research performing organisations, funding agencies, and cooperate with the private sector and other stakeholders. Download the proposal

The SCAR Working Groups form an inspiring network of motivated peers. They offer unique platforms to develop R&I agendas, co-construct European R&I partnerships, and exchange experiences and best practices. There are currently nine SCAR Working Groups.



AE - Laying the groundwork for a European Partnership on agroecology

The SCAR Agroecology Strategic Working Group (SCAR AE SWG) is the cocreation platform that currently prepares the candidate European Partnership on "Accelerating farming systems transition: agroecology living labs and research infrastructures". Since its creation in January 2021, the SCAR AE SWG has made huge progress, with the publication of the partnership dossier in March 2022. The final draft Strategic Research and Innovation Agenda (SRIA) is expected by the end of the year. Find out more.

AKIS - Training and education in agriculture spotlighted

The 11th meeting of the SCAR Agriculture Knowledge and Innovation Systems SWG (SCAR AKIS SWG) took place on 6 and 7 April in 's Hertogenbosch (NL). The meeting focused on four topics: Member States' CAP AKIS plans, strengthening the multi-actor approach, practice-oriented national knowledge reservoirs, and how to integrate advisors in the education system on agriculture. <u>Read more.</u> ARCH & FOREST - Joining forces against imported deforestation

Earlier this year, SCAR ARCH SWG and SCAR FOREST SWG joined forces to identify research gaps and needs in order to better address the issue of reducing the deforestation and forest degradation triggered worldwide by European imports of commodities (raw materials, food, timbers,...). The goal is to publish a policy brief on the scientific challenges for Europe to reduce the so-called "Imported deforestation". An expert group dialogue held on 2 and 3 February was the first step in the process. Find out more.

"European bioeconomy policy: stocktaking and future developments" outlines the state of play of the European Bioeconomy and assesses the progress in the implementation of the 2018 EU Bioeconomy Strategy and its Action Plan. The SCAR FOOD SYSTEMS SWG is developing the Strategic Research and Innovation Agenda (SRIA) of the candidate Sustainable Food Systems (SFS) Partnership. The SRIA will be developed with an interactive co-creation process involving experts and SCAR FS SWG members. bioeconomy-relevant topics in Horizon Europe. The analysis will focus primarily on the cross-cutting issues of the bioeconomy, take stock of the current situation, and identify possible fields of action for future funding. The SCAR AH&W CWG is the co-creation platform for preparing the candidate Animal Health & Welfare Partnership. As certain animal diseases and resistant germs can be transmitted to humans. combating them has also a beneficial effect on human health. The AH&W partnership will carry out research and will promote cooperation between the partners so that they are better prepared for future disease outbreaks. This goal is backed-up by specific objectives such as finding strategies for land contamination, as well as ideas on how to implement carbon-farming practices.
